The papers document correspondence and business records for the family's ranch. Robert's father, Louis B. Hanna, a former governor of North Dakota, was also involved in the ranch.

10684 Roy H. "Andy" Andersen Collection

Collections includes audiotapes, film, and corresponding papers created by Roy H. "Andy" Andersen. The audiotapes consist of radio interviews by Andersen with Governor William Guy, President Lyndon B. Johnson, US Senator Edward (Ted) Kennedy, and businessman Robert McCarney. There is an oral history with Andy Andersen about his life and the changes in the radio broadcasting business. The film in this collection contains segments of urban renewal project contruction in Bismarck and demolition scenes, Mandan rodeo, Gene Autry, Sanish, N.D., Buffalo Lake, N.D., and Bismarck, N.D. scenes.

10787 Arthur A. and Grace Link Papers

Records reflect the life, family, career, and day to day operations of Governor Arthur A. Link, who served as North Dakota legislator, Governor, and representative from North Dakota to the 92nd Congress.

The collection consists of correspondence (relating to legislation, organizations, committees and politics, personal letters, and constituent concerns), speeches and statements by Link, letters to the editor, news releases, campaign and inauguration materials, personal schedules, records of elections, political parties, and candidates, documentation of legislative sessions and the 92nd United States Congress (including bills, calendars, legislative and lobbyist materials, correspondence, research material, and drafts), subject files for the many topics Link was interested and involved with, files from the committees and organizations with which he worked throughout his lifetime, personal papers (including awards, programs, volunteer and philanthropic (Continued on next page)

material, education and coursework, and Grace Link's personal papers), maps, pamphlets, photographs, radio tapes and scripts.

10864 John E. Davis Papers

The black and white and color photographs include autographed photographs, composites, group photographs, and individual portraits relating to Davis as legislator, Governor and former Governor, Head of the American Legion, and as the director of the US Civil Defense/Civil Defense Preparedness Agency. The collection also contains certificates and distinguished service medals.

10955 Roger Allin Bond Papers

Contains correspondence, photographs, and other material related to Mr. Bond and to his namesake, the Territorial Governor Roger Allin. Video of the presentation of the material to Governor Schafer, 1995.

10971 Mark E. Nelson Papers

Collection consists of material related to the history of Dakota Territory and North Dakota. Files primarily consist of correspondence, biographies, clippings, autographs, and photographs of many North Dakota and Dakota Territory Governors and politicians. Collection also includes miscellaneous early correspondence, assorted Territorial contracts and receipts, biographical clippings of various people (mostly early ND political candidates), an early map of Dakota, and a U.S. House of Representatives Report.

11065 Walter Welford Papers

Consists of Welford's oath of office, wedding announcement, marriage certificate, passport, a medal, ribbon, newspaper clippings, post cards, and photographs. Welford served as the Twentieth Governor of North Dakota, 1935-1937, after Thomas Moodie was disqualified. Welford was a member of the North Dakota State House of Representatives, 1906 & 1908, served in the North Dakota State Senate, 1916 & 1918, and was Lieutenant Governor of North Dakota in 1934.

11274 John E. Davis Papers

Consists of ten scrapbooks containing newspaper clippings and photographs of John E. Davis's time campaigning for governor of North Dakota (1955-1956), his time as the National Commander of the American Legion (1966-1967), and as the Civil Defense Chief (1969-1976). Also included in the collection are three national American Legion 16mm films. John E. Davis served as governor of North Dakota for two terms from 1957-1961.

11131 North Dakota Governor's Residence Oral Histories

Consists of six interviews, on DVDs, of former first ladies and children that lived in the governor's residence, as well as, the architect. People interviewed were Rick Davis, Nancy and Deb Guy, Jean Guy, Grace Link, Bob Ritterbush (architect), Kari Jones (daughter of Nancy Schafer), and Barb Olson. Interviewers were First Lady Betsy Dalrymple and Sarah Johnson in 2011-2013, covering the time period from 1957-2010.

Wedding announcement and photograph of Marie Betzy Peterson and Henry Holt; record of birth from the Zion Lutheran Church of Elgin, Illinois, and other documents to establish citizenship; correspondence: general, about Holt's health, the National Reclamation Association, Norwegian Relief, North Dakota Resources Board, Tri-State Waters Commission, Conference of Governors, War Manpower Commission, legislation, and political appointments; a speech on farm labor; telegrams and sympathy letters to Marie Holt after the death of Henry (including from President Franklin D. Roosevelt, Governor Moses, C. J. Hambro (Norwegian journalist, author, statesman and politician), A. I. Johnson (Vice Consul of Norway), Olav V (Crown Prince of Norway), and Senator William Lemke; stock certificates; and memorial resolutions passed by the North Dakota Legislature and other organizations after Henry's death.

Letter from Shafer to Mrs. D. R. Jones, Wahpeton, North Dakota, concerning defeat of Republican candidates in the 1932 primary elections.

20153 John Miller Papers

Papers consist of a ledger sheet from the Bower, Miller, and Dryden Company, Dryden, New York; photographs of the company; and a copy of the Dryden Illustrated News.

20202 Abraham Lincoln Correspondence

Copy of a letter from Lincoln appointing Newton Edmunds Governor of the Dakota Territory.

20293 John Moses Scrapbooks

Scrapbooks contain political memorabilia, including photographs, tickets, letters, and buttons relating to state and federal elections in 1936.

20914 Frank A. Briggs Papers

The Frank A. Briggs Memorial Scrapbook contains death notices and obituaries from various newspapers in North Dakota and the United States. Several of the obituaries contain very detailed biographies. These are numerous, as the governor died in office on August 10, 1898. There are also copies of the eulogies delivered by various state officials and friends at the state capitol. The scrapbook contains a description of Briggs' nomination for governor in 1896, and a few copies of campaign speeches made for him. His inaugural ceremony is detailed, including the notices of his daughter's death. She died in Minneapolis (MN) while he was taking the oath of office. Clippings of the Republican convention in 1894 when Briggs was nominated for State Auditor are followed by newspaper clippings about that campaign. Letters of recommendation about Brigg's ability as a printer, a picture of the Briggs cemetery monument, presumably in Howard Lake (MN) where the governor was buried, social notes concerning Mrs. Briggs' life in Bismarck (N.D.) after the governor's death, and a marriage announcement of the 1905 remarriage of Mrs. Briggs complete the contents of the scrapbook.

20933 Frederick C. Angliss Papers

Letters of appreciation from Governor L.B. Hanna to Angliss, a fellow Republican, member of the North Dakota National Guard, and Dickinson (N.D.) businessman. A biographical sketch of Angliss is available.

20942 Louise (Aandahl) Stockman and Mary (Langer) Gokey Oral History

Oral history interview with transcript, contains interviews with former governors' daughters, Louise Stockman and Mary "Mimi" Gokey, conducted by Larry J. Sprunk in May 1983, and discusses the daughters' views of the mansion.

20946 James Else Papers

The collection of letters are written by Roger Allin, fourth governor of North Dakota, to a friend and former employee, James Else, about being a territorial legislator and about mutual friends in the Park River (N.D.) area.

21015 Roger Allin Papers

Material Certificates, photo, and memorabilia of the territorial governor. Donated by namesake Roger Allin Bond to Governor Ed Schafer during an Arbor Day celebration.

21279 Lydia Langer Papers

Broadside promoting the campaign of Lydia Langer for Governor. The original portrait on the poster was taken by Andreas Risem (Bismarck, N.D.).

21428 Rial Cheadle Papers

Correspondence between W. F. Reden of Sioux Falls (S.D.), Governor John Moses, and Florence Davis regarding the authenticity of a story in a newspaper clipping Reden sent to the Governor regarding a North Dakota man named Rial Cheadle who participated in the Underground Railroad.

21521 August R. Geving Papers

Two letters from Governor William Langer to August V. Geving, Jamestown, ND, regarding conditions and issues for postal and railroad workers in North Dakota.

21537 Walter Ramler Papers

Three items. A letter Ramler sent during George Sinner's campaign for his second term as Governor. There are some interesting presentations of his legislative pedigree, accomplishments, etc. This letter is of a particular nature appealing to his alumni at St. John's University. There is an additional one-page note (letter) from Sinner's campaign manager apologizing for not thanking for a past contribution. Additionally, there is a third letter from his Minnesota campaign organization notifying alumnus of a private get-together at the Tower room of the IDS tower; ostensibly to raise funds for the campaign. Items give a more personal view of the election push of 1988.

30012 Dakota Territory Records

After statehood, the Dakota Territory records were divided and North and South Dakota each received half of the records. All of the records were microfilmed so both states would have them. The records are from the Supreme Court, Legislature, Governor, the Secretary (now Secretary of State), Agriculture, Public Examiner, Public Instruction, Public Health, Schools and Colleges, Hospital for the Insane, Penitentiary, Counties, Military, Federal Relations, Exhibitions and Fairs, Insurance, and Murder Trials.
