Homesteading and Settlement in North Dakota

President Abraham Lincoln signed the Homestead Act on May 20, 1862. Under this act, many people moved to North Dakota to homestead the land. Joseph Rolette, Jr. was the first to file a claim in northern Dakota Territory. Nelson E. Nelson was the first person to acquire a homestead patent in northern Dakota Territory. This pathfinder will lead researchers to several resources available at the North Dakota State Archives highlighting the Homestead Act of 1862 and the challenges of settlement.

Research dates from circa 1870-circa 2000. Genealogy was compiled circa 2000-2015.
