# North Dakota State Archives | Subject Guide Lynn Frazier: The First American Governor Removed From Office by Recall

Lynn Frazier was the twelfth governor of North Dakota, but the first public official to be removed from office by recall. This pathfinder will lead researchers to several resources available at the North Dakota State Archives highlighting the governorship and political career of Lynn Frazier.

# **Archival Collections**

## 10070 Usher Lloyd Burdick Papers

Burdick family correspondence, manuscript drafts and copies of articles written by Burdick and others, speeches, correspondence, articles "Your Congressman Comments," legal material, political records, copies of House bills introduced by Burdick, sources used by Burdick for his research, and rare and valuable publications relating to North Dakota, American history and topics of interest to Burdick.

## 10083 Theodore Gilbert Nelson Papers

Records of the Independent Voters Association (IVA), including minutes, articles of incorporation, correspondence, reports, speeches, telegrams, petitions, transcripts of investigations and debates, political ephemera, drafts of legislative bills, news releases, newspaper clippings, publications, and a subscription list of The Independent; and records of the Lincoln Republican League and the Doyle for Governor Campaign Organization. The IVA records relate primarily to Townleyism, the 1921 recall, Non-partisan League, the Langer for Governor campaign (1920), and the investigation of the Home Building Association and other state industries. President, Equity Cooperative Exchange and Secretary, Independent Voters Association.

## 10157 North Dakota Oral History Project Records

Oral history interview transcripts, indexes to recorded oral history interviews, interview referral files, interview files, photographs, lists of donations to the Project, oral history interview transcripts relating to the Governor's Mansion, family histories, biographies, reminiscences, and manuscripts. Most of the records document administration of the Project. Genealogical information and oral history interview transcripts make up the remainder of the collection. Sponsored by the North Dakota American Revolution Bicentennial Commission, the State Historical Society of North Dakota, and the North Dakota Farmers Union, the Project conducted oral history interviews with older North Dakotans and others who were participants in significant events in the history of the state.

#### 10971 Mark E. Nelson Papers

Collection consists of material related to the history of Dakota Territory and North Dakota. Files primarily consist of correspondence, biographies, clippings, autographs, and photographs of many ND and DT Governors and politicians. Collection also includes miscellaneous early correspondence, assorted Territorial contracts and receipts, biographical clippings of various people (mostly early ND political candidates), a early map of Dakota and a U.S. House of Representatives Report. Files on William "Bill" Langer and Senator Gerald Nye include FBI files requested by Nelson in 1995 under the Freedom of Information Act.

#### 11022 Thomas F. Baker Papers

Personal papers of Thomas F. Baker, Inez Schonert Baker and their family. Photographs, career and civic files, including newspaper clippings of Thomas Baker, long-time Bismarck City Auditor/City Coordinator, reflecting his work in budgeting, airport development, and city management as well as his civic involvement with local hospitals, YMCA, and campaigns.

#### 11116 North Dakota Humanities Council, Larry Remele Memorial Fellow Reports

Collection consists of audiocassettes, papers, programs, and reports to the people of North Dakota tabloids by Larry Remele Memorial Fellows of the North Dakota Humanities Council.

#### 20201 Willard G. Bingenheimer Papers

Papers consist of a notebook and other documents relating to Bingenheimer's training at the Ordnance Service Course on the Aberdeen Proving Ground in Maryland, French post cards, and two pilot's licenses. Also included in the collection are two panorama photographs of Nonpartisan League Delegation from North Dakota in Washington, DC on December 18, 1933.

Copies of nine completed membership applications.
