Statehood and the Constitution: A New Frontier

The Enabling Act of 1889 allowed Dakota Territory to apply for statehood as two separate states. The North Dakota Constitutional Convention opened on July 4, 1889. The state constitution was ratified on October 1, 1889. This pathfinder will lead researchers to several resources available at the North Dakota State Archives highlighting North Dakota's admittance to the Union as a state and the North Dakota Constitution.

Archival Collections

10001 Burleigh Folsom Spalding Papers

Autobiography, correspondence, account books, autograph book containing signatures of delegates to the North Dakota Constitutional Convention, letterpress copy books, legal documents, poetry, speeches, and attorney dockets relating to law practice. The records relate primarily to Spalding's personal, business, and political activities. The collection includes the records Capitol Commission (1883-1886), the "Admission-As-A-Whole Commission" (1887), and a roster of North Dakota county political committee members, 1904.

11354 Ephemera Collection

The ephemera collection contains a variety of materials which are arranged first by size, then by topic (in alphabetical order). The collection primarily Printed material such as posters, tickets, programs, brochures, and pamphlets. The first group of materials is letter size or smaller, the second group is larger than letter size and smaller than 11x17" and the third group is larger than 11x17". Also includes digital files in SADR.

11493 Doreen Chaky Research Collection

Research for the book *Terrible Justice*, numerous freelance articles, and work with the Williston Oil Reporter, as well as article drafts and notes.

11494 Alexander Flemington Papers

Consists primarily of Flemington's personal and professional correspondence, as well as printed material from his school years and legislative career, and copies of reports and journals from the 1887 Territorial Convention and the 1889 North Dakota Constitutional Convention, with legislation proposed by Flemington identified.
